**TEXT-MESSAGE ALERTS:** The Cuyahoga County Court of Common Pleas and Adult Probation Department has the ability to send text-message alerts when hearings or appointments are set, as well as reminders leading up to the event. This includes emergency closing notifications. The Court encourages all persons with a pending case in the General Division of the Common Pleas Court to opt into this service.

**SUMMARY TERMS & CONDITIONS:** Our mobile text-messages are intended for individuals with business with the Cuyahoga County Court of Common Pleas and are delivered via USA toll free number (844) 589-8573. You may receive multiple messages per month for text alerts depending on the activity of your case(s).

**MESSAGE & DATA RATES MAY APPLY.** The service is available to persons with text-capable phones subscribing to carriers including AT&T, Verizon Wireless, T-Mobile, Sprint, Virgin Mobile USA, Cincinnati Bell, Centennial Wireless, Unicel, U.S. Cellular, and Boost. For help, text **HELP** to (844) 589-8573, or call +1 (216) 443-8560. You may stop your mobile subscription at any time by text messaging **STOP** to toll free number (844) 589-8573. To opt back in, text **UNSTOP** to toll free number (844) 589-8573.
