


*Time to Disposition*  
*Criminal Matters*

Time to Disposition is used in conjunction with Measure 2 Clearance Rates and Measure 4 Age of Active Pending Caseload, is a fundamental management tool that assesses the length of time it takes a court to process cases. It compares a court's performance with local, state, or national guidelines for timely case processing. When the underlying data conform to the State Court Guide to Statistical Reporting, the measure takes into account periods of inactivity beyond the court control (e.g., absconded defendants, cases suspended pending decision on an appeal) and provides a framework for meaningful measurement across all case types.

The following Time to Disposition charts are based on the Ohio Supreme Court time standards for criminal cases:


Current Time Standard - 100% of all criminal cases disposed within 180 days from judge assignment



Cuyahoga County Common Pleas Court*



Cuyahoga County Common Pleas Court**










*Time to Disposition  
Foreclosure Cases  
Cuyahoga County Common Pleas Court*

The following Time to Disposition charts are based upon the Ohio Supreme Court's time standards for Foreclosure cases. It should be noted that Cuyahoga County does have a Foreclosure Mediation program. This program assists with resolving Foreclosure cases earlier and prior to eviction. In many instances, cases that are mediated provide home owners with the ability to stay in their homes while at the same time entering into a loan repayment plan and/or utilizing several federal loan repayment options. Although Cuyahoga County's Foreclosure Mediation has been successful and recognized as a national model, it does expand the time needed to resolve Foreclosure cases beyond the Ohio Supreme Court's 12 month time standard.

**2025 Averages: 12 Month Standard: 92%**




**Time to Disposition  
Administrative Appeal Cases

Time to Disposition, used in conjunction with Measure 2 Clearance Rates and Measure 4 Age of Active Pending Caseload, is a fundamental management tool that assesses the length of time it takes a court to process cases. The following Time to Disposition charts are based upon the Ohio Supreme Court's time standards for Administrative Appeal cases. Given that only a small number of Administrative Appeal cases are filed each year, wide fluctuations in the presentment of data can be expected.

Current Time Standard - 100% of all administrative appeal cases disposed within 9 months from judge assignment
